**\$ COVID-19 ECONOMIC IMPACT PAYMENTS:** SSI recipients will automatically receive their \$1200 payments however those with dependents under the age of 17 should go to the IRS's webpage at [www.irs.gov/coronavirus](http://www.irs.gov/coronavirus) and visit the *Non-Filers: Enter Your Payment Info* section.
